
**ORDER GRANTING MOTION TO  
DETERMINE CONFIDENTIALITY OF COURT RECORDS**

THIS CAUSE came before the Court on Plaintiffs HT Investments, LLC, Silver Rock Tactical Allocation Fund LP, and Silver Rock Contingent Credit Fund LP (collectively, "Plaintiffs") and Defendants Lighthouse Family Trust, Lawrence E. White Family Foundation, Patrick L. White, individually and in his capacity as Trustee of Lighthouse Family Trust and as Trustee of the Lawrence E. White Family Foundation, and Lawrence E. White's (collectively, Defendants," and together with Plaintiffs, the "Parties") Motion to Determine Confidentiality of Court Records (the "Motion"). This Court having reviewed the Motion and otherwise being fully advised in the premises, finds that it is

ORDERED and ADJUDGED that:

1. The Motion is GRANTED.
2. The Parties are permitted to file the confidential information identified in the Motion as the “Confidential Motion Information” under seal and such information shall be treated as confidential by the Clerk of Court absent further order from this Court.
3. The named parties to this action, counsel of record for the named parties, the Court, the Clerk of Court, and experts are permitted to view the confidential information in a manner consistent with the parties’ Confidentiality Agreement.
4. The Court finds that the degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in Florida Rule of Judicial Administration 2.420(e) and finds that no less restrictive measures are available to protect those interests.
5. The Clerk is directed to publish this order in accordance with Florida Rule of Judicial Administration 2.420(e)(5).
